

Gitex Campaign
Terms & Conditions

This Gitex Campaign (the “Campaign”) is valid from the 1st of October 2016 until the 30th of October 2016 (“Campaign Period”).

This Campaign will be valid across Samsung Brand shops, Samsung Authorized Retail Stores, Gitex Exhibition in the following emirates in the United Arab Emirates (“UAE”): Dubai, Abu Dhabi, Fujairah, Umm Al Quwaim, Ras Al Khaimah, and Ajman.

The Campaign is valid upon the purchase of Samsung Mobiles, Tablets, and Wearable (the “Product(s)”).

For every AED 1000 spent on the Products, the consumer will be eligible to receive one (1) raffle voucher, and will be qualified to participate in a raffle draw.
